

LEGAL NOTICE AND CONDITIONS OF USE

AUDI SUMMIT FOR PROGRESS

1. Introduction

VOLKSWAGEN GROUP ESPAÑA DISTRIBUCIÓN, S.A.U. (hereinafter, "**VGED**") is a Spanish entity registered in Avinguda del Parc Logístic, 12-20. 08040 Barcelona, España, with Tax Identification Number (C.I.F.) A-60198512, duly registered in the Mercantile Registry of Barcelona in Volume 24.887, folio 171, page number B-80.744, and whose contact email address is atencioncliente@audi.es

VGED adheres to the VOLKSWAGEN Group Code of Conduct, which is available here <https://www.audi.es/es/web/es/modelos/compliance.html>.

These terms of use (hereinafter "Terms of Use") govern the use (including mere access) of the website www.audisummitforprogress.com, including all content and services available on it (hereinafter, the "Website"). Any person accessing this Web Site shall be considered its user (hereinafter, "User" or "Users").

Please read the Terms of Use carefully. By accessing the Website and using the materials contained herein, you acknowledge that you have read, understand and agree to be bound by these Terms of Use. If you do not agree with all or part of these Terms of Use, you should refrain from using the Website.

The User must take into account that the products, services and content that are made available to the Users on the Website may be regulated by specific conditions that, in case of conflict, will prevail over these Terms of Use. Therefore, each time the User uses such product, service or content, he/she will be accepting to be subject to the corresponding particular conditions that may be applicable.

2. Purpose

The purpose of the Website is to provide information about the Audi Summit for Progress event, as well as to offer tickets to attend the event. Users wishing to purchase such tickets must first expressly accept the General Terms and Conditions.

The use of the Website is free of charge. However, it may involve data consumption. VGED is not responsible for the costs incurred by the User in communicating and sending data or Internet connection. Users may consult their telecommunications operators for further information in this regard.

3. Intellectual and Industrial Property

The texts, images, sounds, animations, videos and any other contents of this Website are the exclusive property of VGED or, if applicable, of third parties who have granted a license or authorization to VGED for their use.

In this sense, VGED grants a non-exclusive, non-sub-licensable, non-transferable license to the Users to use the Website, its respective features, content and other available functions, which shall be subject to the rest of the terms included in these Terms of Use, as well as to any other applicable terms of use and legislation. The User is only authorized to view and obtain a temporary private copy of the content for his/her exclusive personal and private use in his/her computer systems (software and hardware), but is not authorized for subsequent transfer to third parties. With the above exceptions, the User may not modify or reproduce, either in part or in whole, nor distribute or communicate this information to the public, without the express written consent of VGED.

For their part, Users grant VGED a non-exclusive, unlimited, transferable, free and sub-licensable license for the use of the contents shared by them through the Website. In particular, but not exclusively, VGED shall have the right to reproduce, transmit, distribute, publicly communicate, make available, extract, reuse and transform such content in any form and for any purpose. Likewise, Users grant VGED a non-exclusive, unlimited, full, transferable, free and sub-licensable license on the data they provide that are not of a personal nature or those data whose personal reference has been deleted (anonymized data). Any other use must be previously authorized.

Users acknowledge and agree that the use of the Website does not imply the transfer of any intellectual or industrial property rights, such as copyrights, trademarks, designs or other rights over the Website or any of its constituent elements, except for the limited license of use granted to Users under the terms provided herein.

All logos, trademarks and industrial designs appearing on this Website fall within the scope of application of the industrial and intellectual property rights registered by VGED, so any form of exploitation, reproduction, distribution, public communication, availability and transformation without the express authorization of VGED is prohibited.

Users grant VGED a non-exclusive, unlimited, full, transferable, free and sublicensable right of use for non-personal data, in particular technical data, or data whose personal reference has been deleted (anonymized data).

4. User Commitment

The User voluntarily and expressly acknowledges and accepts that the use of the Website is done under his/her sole and exclusive responsibility at all times.

The User agrees to comply with these Terms of Use, as well as to comply with any special warnings or instructions for use contained herein.

The Users are obliged not to misuse the Website, as well as not to distribute information or use it for:

(a) Activities contrary to the Law in force, to these Conditions of Use, to morality, good customs or established public order, or for purposes that are illicit, prohibited or detrimental to the rights and interests of VGED or third parties. In particular, copyrights, names or trademarks, as well as privacy rights.

b) Use the Website or any part of it on other private or commercial websites, as well as make commercial use of the Website; or establish hyperlinks or hyperlinks to the Website or any of its contents (unless expressly authorized in writing by VGED).

e) Disclose, extract, reuse, re-send or use in any way, in whole or in part, in any medium or format, any of the data or elements of the Website belonging to VGED without its prior express written consent.

VGED reserves the right to remove from the Website or prevent the display of information or content shared by Users that violates these Terms of Use, third party rights or applicable law and, in particular, the commitments stipulated in this clause. VGED shall retain all other rights it may have against the User, in particular those relating to the initiation of civil or criminal proceedings.

The User guarantees that the information, materials, contents or remarks that do not constitute personal information but that he/she provides to VGED do not infringe the intellectual or industrial property rights of third parties, or any other legal provision.

5. Guarantee exclusion

VGED will make every reasonable effort to ensure the proper functioning of the Website. However, VGED cannot guarantee the absence of service interruptions for the purpose of repairs, and/or maintenance of the Website or lack of coverage or failures in the equipment and/or networks necessary for the transmission of data, which are beyond its control. VGED will take appropriate measures to reduce such interruptions.

6. Responsibility

The User who visits the Website is fully responsible for access to it and the use that may be made of the information contained therein, and undertakes to use the Website in accordance with these Terms of Use and the Law. The User shall be liable to VGED or any third party for any loss or damage arising as a result of a breach of this obligation.

VGED cannot be held responsible for errors or security damage that may occur in the User's computer system (hardware and software) or the files or documents stored in it due to viruses present in the computer used to connect to the services and contents of the Website, due to a browser failure, the use of obsolete versions of the browser or telephone failures, interferences, omissions or disconnections in the operation of the electronic system due to causes beyond the company's control.

The information provided through the Website is indicative and not exhaustive and may not be updated at any given time. Therefore, to the extent legally possible, VGED is not responsible for any errors or omissions in the content of the Website or others that may be accessed through it.

VGED adopts security measures reasonably sufficient to detect the existence of viruses. However, the User must be aware that the security measures of computer systems on the Internet are not entirely reliable and that, therefore, VGED cannot guarantee the absence of viruses or other elements that may cause alterations in the computer system (software and hardware) of the User or in the electronic documents and files contained in that system.

To the extent permitted by applicable law, VGED will not be responsible for failures that may affect the User's server or communication networks, nor for problems resulting from malfunctions or the use of non-optimized versions of a web browser.

VGED reserves the right to deny access to a User upon any indication that the use of the services offered is being made fraudulently, as well as to take appropriate legal action to defend its interests, and to temporarily suspend access to the Website without prior notice for maintenance, repair, updating or improvement operations.

7. Data protection

10. Modifications to the Terms of Use

VGED reserves the right to change the structure and design of the Website, and to modify or eliminate services, content or the conditions of access and/or use of the Website, at any time and without prior notice, so the User should consult these Terms of Use regularly. In the event that these Terms of Use are modified, the date on which the new version becomes effective will be indicated at the top of the Terms of Use. If the User continues to use the Website after the new version has been published, he/she will have accepted the new Terms of Use.

11. Notification of incidences and possible infractions

VGED respects the rights of third parties and the applicable legislation. The Website User is obliged to do the same.

12. Independence and integration of clauses

It is understood that any situation that seriously

harms the interests of any of the parties, or that affects the very object of the present Terms of Use, is essential. Said clauses must be replaced or integrated with others that, being in accordance with the law, respond to the purpose of the replaced clauses.

13. Final provisions, applicable law, competent courts of jurisdiction

The present Terms of Use are governed by the common Spanish legislation. If the User is a consumer, these Terms of Use shall also be subject to any applicable local legislation.

Any dispute that may arise from the use of the Website or these Terms of Use shall be submitted to the competent courts of the city of Barcelona (Spain), and, in the case of a User acting as a consumer, to the court of the place of residence corresponding to the consumer User.
